



I intend and agree to volunteer for Paceline Ride. I understand that the nature of volunteer activities that I may perform in my capacity as a volunteer may involve physical activities, contact with unidentified and/or unfamiliar persons, or other potential risk of bodily injury or damage to property. Knowing this and in consideration of being allowed to volunteer, I hereby sign this waiver and release in favor of Paceline Ride, and it's officers, directors, employees, agents, sponsors, volunteers, event management firms, administrators, successors and assigns (referred to collectively as the "Released Parties").

I hereby release, waive, discharge, covenant not to sue, and agree to indemnify and hold harmless for any and all purposes the Released Parties from any and all liabilities, damages, claims, demands, or injuries, including death, that may be sustained by me resulting from or arising out of my service as a volunteer. INCLUDING ANY SUCH DAMAGES, CLAIMS, DEMANDS, OR INJURIES, INCLUDING DEATH, CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR OTHER ACT OR OMISSION OF THE RELEASED PARTIES, OR BY A PRE-EXISTING DEFECT.

I understand that this agreement to indemnify and hold harmless does not apply to injuries caused by intentional or grossly neglected conduct. I understand and agree that this Waiver and Release shall bind my heirs, assigns, successors, and personal representatives, including my spouse and members of my family, and shall be governed by the laws of the State of Georgia.

I authorize and consent to utilization of my name, image, or likeness in any videotape, film, newsprint, written advertisement or other material in connection with the event, subsequent events, or related activities.

I authorize and consent to receive text messages to communicate event related emergency management messaging only.

I understand that as a volunteer, I may become privy to confidential information about Paceline Ride. I agree to maintain the confidentiality of any information marked "confidential" as well as any information about Paceline Ride's internal procedures, business operations, personnel information and the like that is not otherwise publicly disclosed by Paceline Ride. I will not use any confidential information in any manner that would be detrimental to Paceline Ride, and I will avoid any actions that might impair the reputation of Paceline Ride.

#### **MINOR PARENTAL CONSENT:**

I, being the parent or legal guardian of (the "Minor") hereby consent to and authorize the Minor to act as a volunteer for Paceline Ride. I acknowledge and agree that activities performed by the Minor as a volunteer will be performed strictly on a voluntary basis, without any pay, compensation, or benefits. I agree and understand that the Minor must comply with the guidelines established by Paceline Ride and that failure to do so may result in the Minor's immediate removal as a volunteer.

I am aware of the nature of the activities to be performed by the Minor as a volunteer and recognize that in performing volunteer tasks, a risk of harm or injury exists. I agree that all volunteer activities are to be performed by the Minor at the Minor's risk and I assume full responsibility therefore.

On behalf of myself, the Minor, and our respective heirs and personal representatives, I agree not to hold or attempt to hold Paceline Ride, it's officers, directors, employees, agents, sponsors, volunteers, event management firms, administrators, successors and assigns (referred to collectively as the "Released Parties") for any and all claims, demands, causes of action of any nature or cause, for any such injury or damage incurred or suffered by the Minor.
